The other major change is that this *Newsletter* will now be published quarterly instead of every other month. It’s quite good fun to produce but it can be a bit of a chore, depending on how many people contribute. ## PLANNING MATTERS

**T**HE BIG NEWS in the last *Newsletter* was the application by Urban Splash to develop the former Wills Office Block in Crox Bottom. This was passed by the South & East Development Control Committee, with the same comments expressed that we had made about public access to the lake. We all want to see this exciting project succeed, and discussions are continuing about the detailed arrangements for access.

The application for a stone-crushing plant on part of the quarries area of Manor Woods Valley, which I reported in the last *Newsletter*, hasn't moved on very much. The further information which was requested has apparently not yet been enough to satisfy all the relevant departments, so we are still some way from a decision. We continue to oppose this proposal because of its effect on the existing Site of Nature Conservation Interest and because it is adjacent to the proposed Local Nature Reserve - which is now, we are informed, a step closer to legal designation.

We also reported that we were querying the status of the sheds and shipping containers which make up the club house of Highridge United Football Club on Highridge Playing Fields. Planning Enforcement have investigated and have told us that there is no action they can take. Some of the 'buildings' have planning permission, and the remainder have been in place longer than the five years necessary to qualify as 'established use'. Unfortunately, there is still no sign at all that the development of the Playing Fields will ever happen.

It has seemed in the past as though the saga of the development at the Old Vicarage, Bishopsworth, would never end. There was important good news when the Planning Inspector rejected the developers' greedy application for a further two bungalows in the grounds. We have now written to the City Council to encourage them to take the necessary steps to oblige the owners to carry out the landscaping work which they have been postponing on the grounds that there would be further building.

Finally, you may have noticed that the old toilet block next to the 'Elm Tree' pub has been demolished. We have no objection in principle, but we were surprised - to put it mildly - that there was no planning application to demolish in the conservation area. An application would have allowed us to get involved

in the sort of constructive talks we have asked for on what should be done with the land - we would like further tree and bulb planting, and some tidying up work on the adjacent hedge. The toilet block came under the Neighbourhood & Housing Services Department of the City Council, which makes the absence of a planning application even more disturbing. There is a size below which a structure can be demolished without permission, but it's difficult now to check whether this applied! The block could just have been below this size (115 cubic metres), but we doubt it. We have asked for an investigation.

## IMPORTANT NEWS ABOUT WASTE COLLECTION

*HANNAH GRINTER of the Neighbourhood & Housing Services Department of Bristol City Council has provided this note on the new waste collection arrangements:*

Bristol City Council has introduced new kitchen, cardboard and garden waste collection services in your area.

You should have received a brown 5-litre kitchen caddy that can be used to put food waste in. Food that can be put in this caddy includes:

- eggs, fish, meat, bones and dairy products
- vegetables, tea bags, salad and fruit
- bread, cereal, pasta and rice.

Householders should also have received a lockable, brown food waste bin to be kept outside their home into which they can put the food waste from their kitchen caddy. Food can be wrapped in newspaper and put in this bin. *No plastic should be put in this bin.*

Remember there is the option of buying a green bin for garden waste such as grass and cuttings. For just £21, you can buy a garden waste wheelie bin and for 55p a week (£29 a year) it will be emptied on collection day. There are also compost bins available at £14 plus £3 delivery. Subsidies are available on both the green bins and compost bins.

Collections will be every week for the black box (recycling); the brown kitchen waste bin; cardboard folded and placed by kitchen bin; and the green garden waste bin (optional). The black wheelie bin for rubbish will be collected every other week.
