A **NOTHER** packed *Newsletter*, which means that I shall squeeze in some planning updates here. The latest news - and it's good news - is that Brunelcare have now formally received planning permission for the development of Very Sheltered Housing on Queens Road (the 'Redhouse' site).

The other planning updates are to do with enforcement rather than new applications. I've always said that without effective enforcement of planning permissions - seeing that what's built is what was actually agreed - then the whole development control system is an elaborate bluff. There are some good people in the Council's enforcement team, but they can't monitor every development in the city, and often the only way they know that something is amiss is when someone tells them. M.V.C.G. can take credit for two satisfactory results on this front.

At VALLEY HEIGHTS (the former Esso garage on Bishopsworth Road), we pointed out that the wall had been built without gaps for railing panels, which had been shown in the drawings. Fortunately, this didn't become an enforcement issue, because when the planners contacted the developers they responded correctly, and the much improved wall is now in place.

At THE PARADE, BISHOPSWORTH (Matties block), on the other hand, our report that the agreed landscaping hadn't been done was met by the owner with prevarication, obstruction and downright stupidity. When the Council's enforcement team took it up, it inevitably became a legal matter, and therefore took some time. I'm pleased to report that justice was eventually done and the owner (now the previous owner) has been fined £5000 plus costs for failing to comply with planning requirements. As we reported last time, there is now a new owner, and we look forward to progress here.

We have now obtained a copy of the landscaping plan for the rear of the 'Valley Heights' development of flats in Bishopsworth Road. After a meeting on site we sent our comments to Julian Cox, our Community Park Manager, who has passed them to the relevant person in the Planning Department. We will be able to monitor the work when it starts.

Our only picnic table was badly burnt a few weeks ago. We reported it immediately and it has now been refurbished by the Council's contractors - well done for the quick response!

One of our members noticed some offensive graffiti on two benches. She reported it to the appropriate service in the Council (telephone number: 0117 922 3838) and it was removed within a few days.

If you happen to live near Manor Woods Valley or walk through regularly do not hesitate to inform the Police if you see anything suspicious or notice vandalism. BRISTOL PARKS FORUM CONFERENCE

THIS MEETING at the Gloucestershire Cricket Club on 15 September was attended by about 60 people from local volunteer groups, Friends of various parks and green spaces and officers from Bristol City Council. It was a very friendly gathering because nearly everyone was concerned about their own local green space and its future. Len Croney began the talks by saying how important parks were to any community and how much effort was required to keep them open. Through his long working connection with various leisure, amenity and council bodies he stressed it was important that information was shared and that basic plans were agreed upon.

The next speaker was Peter Wilkinson, Head of Bristol Parks, who has often visited the Malago Valley. He was given the tough task of explaining a 20 year plan for which funding of £87 million was sought. He explained that this would come from Bristol City Council, the Lottery and monies from developers who would be expected to contribute on completion of new housing. Although the fund seemed large, to me anyway it appears impossible to rely on such sources as a Lottery or the E.U. so far into the future. Peter carefully explained that houses built to look out on green space were more valuable than those which backed onto open ground, where security could be more problematical. This could encourage new developments to be built round greens created within them. He did say that some odd parcels of land, as yet to be designated, could be sold to provide a small proportion of this £87 million in future. As well as regular maintenance, the money would also expand and replace equipment and ensure best practice was followed in the management of all Bristol's parks. Peter explained that various sorts of outdoor facilities should be within a short time of walking rather than a specific distance of everyone. Young children, wild areas, sports fields and facilities, play equipment and natural materials, seats and so on were included in this strategy. He stated that what any area actually had depended on the nature of the park, its location near railways for example, or flatness. A lot of this material is shown in the 'Bristol's Parks and Green Spaces Strategy' discussion document, available from Bristol City Council. This looks very good on paper, but it is a long time to spread future developments over, in a world which is going through its own transformations, which may well affect the use of space!

Just before lunch a representative of Friends of South Purdown vividly expressed her fears for this area of Bristol's gateway from the M4 and M32 as a school wanted to take down an ancient lime tree and flatten the top of the

hill for a sports field. Although there was no planning permission for any such radical change, the Head of the school was determined to move forward. Perhaps letters or e-mails of support would strengthen their case for leaving this natural area alone.

During an excellent lunch we had time to mingle and exchange ideas about our local park. A slide show including pictures of Manor Woods Valley and its proposed Local Nature Reserve were repeated on a big screen.

Later, another presentation about the funding and nature of future planning in parks was introduced. There was some debate about the sale of land to developers and the amount they were expected to contribute to the overall strategy. Some of the detail of this is still very much in the air. Many people had things they wanted to discuss but time, as ever, was against them. A new Chair of the Forum was voted in and other existing officers have changed places. This election took only minutes!

The final very brief presentation concerned trees in the street. Most of the delegates wanted more, but there appeared to be a gap in the thinking of the Highways Department who took down damaged trees, or those thought to be dangerous, and who did little to replace these with new specimens. The Parks Department were encouraged to liaise with Highways and find places for new and cared for trees of relevant native species to be installed where ever possible.

I am sure there will be detailed minutes of this very interesting meeting available from the Forum. It was a worthwhile gathering to hear what sort of ideas were in the offing, and I encourage anyone who represents an open space to get along next year if they can.
